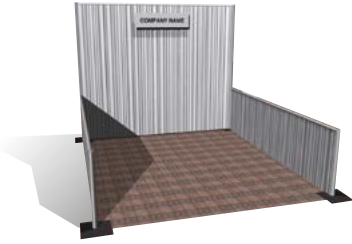

- SPACE ONLY: Nothing will be provided but the exact floor measurements of the booth. The venue is carpeted.
- PIPE AND DRAPE: Booth package consists of a pipe and drape construction with:
